AANR continues to work with the very small clubs (generally those with less than ten members) to help them develop and increase their membership ranks. Unfortunately, there is an administrative burden on both AANR and the regional organizations to support these clubs. The clubs in this size category exist in all seven AANR regions. It is possible that when the development options are exhausted, some of these clubs (for example, with only one or two members) may be asked to relinquish their AANR charter.

The topic of charter relinquishment, or removal — depending on your point of view, will be specifically on the agenda for the AANR trustees, at the annual meetings, next week. AANR-East is bringing forward four clubs for charter removal. The reason for all is very few members and no expectations for any change. In addition, AANR-WC is bringing forward the charter for Sol Sante. Sol Sante has indicated they have no interest in remaining as an AANR club. Incidentally, they have not had any AANR members since 2019.

Beyond these five specific clubs there are number of similarly sized clubs - across all seven AANR regions. Do any of you have any advice as to what AANR should do with these very low member count clubs?

The annual AANR meetings are scheduled for the next week, 2022-08-10 to 12. They will be held at Suwannee Valley Resort, located in northern Florida.

#### Website – Bob Dixon

Our domain registration fees continue to be paid, on an as-due basis. This is for both aanrwc.com and weanr.ca

A previous board member acted as webmaster until she resigned from the board. The web mastering role has been re-taken over by my daughter, Cayly. She has done the role for about four of the last five years. I act as the website coordinator while she does the technical stuff.

#### Social Media / Facebook - Greg Hastings

With the loss of two supporting members for social media we have not added a lot of content on the AANR-WC Website this year. However, we have more than doubled our following this year with 241 people following the page. We have spread the word about Green Haven raising money to purchase the land their club is on, we have promoted the Edmonton Naked Bike Ride, and the activities by Calgary Nude Recreation. We also continue to post articles on Social Nudism and body positivity. We would encourage all members to post their nude experiences in a "Facebook Friendly" way, so we can celebrate nudism in Western Canada.

#### Club Liaison - Greg Hastings

AANR-WC has had an interesting journey this year after the unsuccessful dissolution vote in 2021. The question that now must be asked is, "what does success look like for AANR-WC?" I believe the answer lies in relevance to AANR-WC members and clubs, and making connections to those members and clubs that matter. This becomes a bit of a sales effort to bring affinity to AANR-WC.

To this end, AANR has been working on setting up Meet and Greet socials with our established clubs. We have categorized and will be working with our 100% clubs first, and then those who are AANR optional. Next year, we will be having conversations about how we can connect with Nudist groups who are not AANR affiliated.

It is through the relationships we build with our AANR members and clubs that will bring connection and relevance with AANR-WC.

#### Government Affairs - Greg Hastings

Much of the activity in North America has been centered around the fight to keep Little Beach in Hawaii a nude beach. A combination of COVID violations, lewd and drunken behavior, and the attention of conservative politicians has turned Little Beach into a textile beach. There is a group that is working hard to fight this movement, but at this time, the law is against them.

Closer to home, Petition E-3999 sponsored by British Columbia MP Elizabeth May went out this spring to repeal Criminal Code 174 making nudity illegal in Canada, and insert the language that public nudity in and of itself is not indecent, obscene, or a nuisance. The petition has already reached the minimum 500 votes to be considered in the House of Commons.

Elizabeth May does not support this motion, but believes that her constituents should have the right to submit bills. It is likely that this motion will be tabled in the Fall Session of Parliament, at which time it will be critical for nudists in Canada to write a letter supporting the motion. A letter writing campaign will be forthcoming.

AANR is working with the Petition's originator to help spread the message to members of Parliament.

#### 2023 Convention / AGM Host Club Bids

Application to host the 2023 AANR-WC AGM (Attachment #4)

Bylaws -7.01

Bids are accepted 1 year in advance and the delegates approve the host site of the convention / AGM for the following year.

If there are no bids, then the AANR-WC board arranges a host site.

One official bid was received to host the 2023 AANR-WC Annual General Meeting. The bid was from Green Haven Sun Club for the long weekend (August 5,6 & 7, 2023) in conjunction with their 50<sup>th</sup> Anniversary and 1<sup>st</sup> year as property owners.

There is a possibility that Helios is interested in hosting the AANR-WC AGM / Convention the following year as it is their 60<sup>th</sup> Anniversary in 2024.

Mark Huenison explained that the region is trying to encourage clubs to host an AGM or Convention / AGM by giving a club \$300.00 for an AGM and \$1,500.00 for a Convention / AGM. The \$1,500.00 for a Convention / AGM hasn't attracted interest but \$300.00 has been paid out.

Motion #6 Bob Dyce motioned to accept the bid from Green Haven Sun Club to host the 2023 AANR-WC Annual General Meeting.

Second by Laura Guilbault Carried Unanimously

#### Election (4 - 10 Directors) - Mark Huenison

This is an election year for AANR-WC, with all positions for a two-year term.

Seven directors from the previous board agreed to let their name stand for re-election. They are Mark Huenison, Sharell Kopp, Debbie Huenison, Greg Hastings, Bob Dyce, Laura Guilbault and Mark Amyotte. There were no nomination from the floor.

Three of the previous board of directors will not be letting their names stand for re-election. Mark Huenison thanked Tom Dunn, Bob Migliore and Daniel Jackson for their time on the AANR-WC board.

Motion #7 Bob Dixon moved the slate of 7 names - Mark Huenison, Sharell Kopp,
Debbie Huenison, Greg Hastings, Bob Dyce, Laura Guilbault and Mark
Amyotte as directors for a two-year term 2022 – 2024.
Seconded by Laura Guilbault Carried Unanimously

Mark thanked everyone that was returning to the board. If anyone is interested in being on the board, there are still 3 director positions available. The president can appoint a person and the board ratifies the appointment until the next AGM. It would be great if someone from B.C and Manitoba would step forward. Then there would be a director from each province.

The Federal not for profit requires that we elect 4 to 10 directors. With 7 elected, we have met our obligation.

The incoming board of directors appoint the 4 officers' positions (President, Vice-President, Secretary and Treasurer) at the inboard meeting.

#### Proposition 2022-01

AANR members approved changing the name of associate members to direct members as presented on the 2022 AANR voting ballot so AANR-WC must revise our bylaws to reflect this change and submit the revised bylaws to Corporations Canada.

This wording change is required to reflect changes approved by the AANR membership and to maintain wording consistency throughout the association.

#### Purpose

The AANR proposal was approved so AANR-WC is required to update our bylaws to reflect this name change. This name change occurs approximately 22 times throughout the AANR-WC bylaws. AANR-WC proposition 2022-01 will cover all name changes within the bylaws rather than identifying each change individually. AANR-WC bylaw changes require 30 days notice to the membership and a 2/3 majority vote to pass.

AANR-WC proposition 2022-01 provides approval to changing the name of associates to direct within our bylaws so we are consistent with the national association.

#### AMERICAN ASSOCIATION FOR NUDE RECREATION - WESTERN CANADA TREASURER'S REPORT YEAR END MAY 31, 2022

Attached is a copy of the May 31, 2022 Balance Sheet with the May 31, 2021 comparison. Also attached is the year ended May 31, 2022 Income Statement with the 2021-2022 Budget comparison. We forecasted a deficit budget of (\$6,905) and we ended the year with a surplus of \$1,213.

#### **Balance Sheet:**

Cash on hand and deposit: \$6,580

- balance in the chequing account as at May 31, 2022 as per the bank statement; \$5,514
- the difference of \$1,066 is represented by outstanding deposits (April and May 2022 membership fees from AANR).

**Invested Funds:** Total market value as at March 31/22 (last statement date) \$53,030. Investment in the RBC Balanced Fund had realized income of \$1,753 (2022); \$720 (2021) and an unrealized gain of \$8,260 (since March 2017).

**Loan receivable:** Green Haven Sun Club loan payment of \$1,000 was received in April 2022, leaving a current balance of \$1,000 as a loan receivable.

Accounts payable: There were no outstanding payables at the year-end.

Legal Reserve: \$205 was added during the fiscal year (\$1/member fee received).

Youth Camp Reserve: No change from prior year.

Unrealized Investment Market Value Adjustment: Note 1: The unrealized market value adjustment of \$8,260 represents the accumulated adjustment to bring the cost to market value at each statement date.

#### Income Statement:

Membership fees of \$2,665 were collected, represented by 205 membership fees, a decrease of 163 paid members from 2020/2021. This decrease is partially due to the late renewals by Green Haven Sun Club, the Van Tan Club and many Associate members in the 2021/2022 fiscal year. As at December 31, 2021 AANR-WC had 373 members (per AANR records) which includes Life members who do not pay annual dues. The revenue collected from membership fees is recorded on a cash basis with no reconciliation of the timing of member renewals. Overall, we have had a decrease in membership over the last fiscal year.

Investment revenue is increased due to the rebound in the market conditions resulting from Covid-19.

A total of nine conference calls were attended by the AANR-WC board during the fiscal year, including the three official meetings held during the AGM.

Host club fees of \$300 were paid to GHSC for the 2021 AGM. An additional \$123 was spent on AANR 90th AANRversary packages and celebration cake.

There were three issues of CNN produced during the fiscal year at an average cost of \$281 per issue. An editor honorarium was provided for one issue of CNN. Effective the March 2021 issue of CNN most members received an electronic version distributed through AANR. This has significantly reduced our CNN costs. Approximately 40 members are still receiving a mailed version.

Board travel to the 2021 AGM at GHSC was \$600 including \$150 for the AANR-WC Trustee.

There were two requests for club advertising rebates during the fiscal year (SCA, GHSC) for a total of \$352.

We donated \$250 to the American Nudist Research Library but this amount was offset by a previous donation of \$250 to the Wreck Beach Bare Buns Fun Run, which was once again cancelled due to Covid. The cheque was never cashed.

#### PROPOSED AANR-WC BUDGET 2022/2023

June 1, 2022 – May 31, 2023

#### Revenue:

- Budgeted for 300 members at \$13/member (no fee increase).
- AGM only for 2022 so there is no convention revenue budgeted.

#### Expenses:

There is little change to many of the budgeted expense lines. Highlighted below are the major changes.

- The trophies still need updating so an amount is included in the budget.
- For the 2022/2023 in-person AGM in August 2022, the \$300 host club fee and the AANR-WC contribution for an anniversary cake and AGM luncheon are included in the budget.
- Budgeted for 3 CNN issues at 40 mailed copies at an average of \$280/issue. No editor honorarium has been included in the budget.
- There is \$1,700 budgeted for Association travel to the 2022 AANR-WC AGM, including most of the board and trustee, being in attendance. There is also \$1,500 budgeted for attendance by the president at the 2023 AANR mid-winter meeting.
- The \$3,000 Membership Initiative Program, has been reduced to \$1,500.
- A new budget line item referred to as Club Liaison Meet & Greet has been added for \$1,500 to enable representatives of the board to hold Meet & Greet sessions at the club level to provide information and promote AANR-WC.

The result of this proposed budget is a forecast deficit of (\$6,755).
